- The digitizing process will begin after a 50% deposit is received on jobs or more than 5 tapes or other payment arrangements have been agreed upon.
- Payment may only be withheld on those items in dispute, not the complete invoice.
- Final payment will be due when the job is completed and reviewed and approved by client. Terms can also be arranged.
- All media will be returned with a job summary sheet listing actual running times of tapes and any issues that arouse during the digitization process.
- All files and media are considered approved after 30 calendar days from shipping date. Any rework requested thereafter will be billable.
- NOVAC represents that it is not the owner of the material to be converted and that it is not responsible for any potential or
  real copyright infringement as a result. Adherence to copyright law is the responsibility of the holder or owner of the material. You will indemnify, defend, and hold harmless NOVAC from and against all liabilities and expenses, including attorney's fees, resulting from any claim of copyright infringement with respect to the material to be converted.
